## UNDERSTANDING THE DIFFERENT **"UL" AND ELECTRICAL MARKS** AND CERTIFICATIONS **USED IN OUR INDUSTRY**

### **UL Certification**

The UL listing service verifies that a manufacturer can make products that fulfill UL requirements, meaning that any product with the UL listed mark is produced by a company that limits product risks that can be reasonably foreseen. UL does not test each product in this case, instead they authorize the manufacturer to test their products and apply the UL listed mark themselves. However, UL does follow up with the manufacturer on a regular basis to make sure they are following correct procedures to test their products.

Products that we manufacture and have been tested by the Underwriter's Laboratory will have the mark shown below. You will notice a file number below the mark that can be verified by the Underwriter's Laboratory as being tested.

## **CSA Energy Efficiency Marks**

The CSA mark shows products have been certified by an accredited third party lab and have met applicable standards as required by North American law. When you work with a CSA Group you will be working with technical experts that understand the standard requirements.

What is RoHS compliance? RoHS compliance means acting in full



accordance with RoHS regulations and documenting your testing for RoHS controlled substances.

MCS installed a new RoHS compliant solder machine this year to meet or exceed the requirements. This unit does not use Lead when soldering.

## What is an IP rating?


You will notice on some of the specification sheets for our products the following: 'Environmental Protection IPxx'.

IP (or "Ingress Protection") ratings are defined in international standard EN 60529 (British BS EN 60529:1992, European IEC 60509:1989). They are used to define levels of sealing effectiveness of electrical enclosures against intrusion from foreign bodies (tools, dirt etc) and moisture.

The xx will be numbers like '65' or '66'.
